Year 10, 11, 12 and 13 Art visit to the Tate Modern, British Museum or V&A Museum

As part of the school's Enrichment programme and in preparation for their respective exams and coursework year's 10, 11, 12 and 13 are expected to visit galleries and complete first hand research on their selected artists. On Tuesday 15th February 2011 Year 10, 11, 12 and 13 will have the opportunity to visit the Tate Modern, British Museum or V&A Museum, here they will see a wide variety of works by leading artists and designers to inspire them in the design and creation of their examination work this term. The visit will cost £12.00 per student. All students should bring a packed lunch.

The coach will depart from Sandhurst School at 9.00 a.m. and return at approximately 3.00 p.m. All students will not be expected to wear full school uniform.

To reserve a place please return the OHA2 form attached to this letter together with the payment slip below and a cheque for £12.00 made payable to Sandhurst School Private Account by **Friday 11th February 2011**. All cheques should have student's name, tutor group and name of the visit on the back. All envelopes should be posted through the letterbox outside the Finance Office. Receipts for contributions will be forwarded back to parents via the students.

It is school policy that no child is disadvantaged by virtue of the fact that their parent(s) are unable to pay. Children in receipt of free school lunches may be eligible to have some or all of the cost of this activity paid for by the school.

- The guarantee element of State Pension Credit

Children who receive IS or IBJSA in their own right are also entitled to receive free school meals. It is also policy that no visit should run at a loss and therefore if insufficient contributions are made the visit will be cancelled.
