Re: Iceland Visit 2018

It is less than seven months before the Iceland visit departs. I am writing to confirm that we now have the final costs for the Blue Lagoon from our tour operator. I informed you during the information evening that the tour company was unable to provide these costs for the date of the original booking. This was because the Blue Lagoon had not released their prices for 2018, I was therefore unable to factor it into the original cost of the visit.

The Blue Lagoon is a unique and enthralling experience for the students, a chance to swim in thermally heated natural pools, is a fantastic way to remember the visit. The extra cost is **£68** per student, this includes entrance to the attraction and towels. This cost will be added to your payment plan.

In order for us to meet our commitment to the tour company, it is imperative that we receive timely payments for the visit. If you have been making these regular payments on time you have my thanks, if you are not up-to-date with your payments, could you please address this as soon as possible. If there are any issues with payment, please contact me at school. The deadline for final payments is **Monday 8th January 2018**.

There is now a google classroom for the Iceland visit, here you will be able to locate a kit list and keep up-to-date with arrangements like the final information evening. The code to access this is **lr5lss**, please sign up to ensure you receive all the available information. If you have not completed an OHA2 medical form for the visit, please do so as soon as possible and return to me in the Geography Department.

We are now in the process of the final stages of booking with our tour operator, in order for this run smoothly, could you please complete the form below with your son/daughter's complete name as it appears on their passport and the expiry date. The passport must be valid for the dates of travel. If your son/daughter is travelling on a passport other than a UK one, please could you let me know. Your son/daughter should also be have a valid EHIC card for the dates that we travel. This will be collected at the final information evening.
