I can order A3 art canvases for them to use at the cost of **£3.99** or you may be able to find a cheaper alternative in 'Poundland', 'The Works' or similar. Should you wish to order the canvas through school, please fill in the reply slip below and I ask for a donation of £3.99. If you choose not to buy a canvas, students will still be able to do their design on paper, but we will not be able to afford the cost of framing their work to display.

Please can your child return the order form with payment to the **Finance Office** by **22nd January**. Please make all cheques payable to Sandhurst School Private Account.

It is school policy that no child is disadvantaged by virtue of the fact that their parent(s) are unable to pay. - Working Tax Credit during the four week period immediately after their employment finishes or after they start to work less than 16 hours per week
- The guarantee element of State Pension Credit
