Re: Year 10 Science Revision Guide (Separate)

Your son/daughter has recently had parents evening where we discussed the importance of regular revision in science. To help prepare for future exams we recommend buying a revision guide to help support your son/daughter's learning at home. As your child is studying for three separate sciences we would recommend purchasing the three revision guides for each subject from CGP as this will then cover all of the relevant science content.

We can currently purchase these three books at a reduced price of **£9.00** (£3.00 each usually retail at £5.95 each). If you wish to purchase the revision guides through the school, please make your payment and return with the reply slip to the Finance Office. The revision guides can be paid for in the usual way by cash or cheque payable to Sandhurst School Private Account, with the student's name, tutor group and "GCSE Separate Science Revision Guide" written on the back of the cheque and also on the front of the envelope. Alternatively, payment can be made online. Receipts for payments will be issued on request.

This reduced price is only available with CGP for a limited time, therefore we ask that all orders and payments are returned to the finance office by the end of term **Friday 11th January**. Any orders after this date will not be able to be processed.

It is school policy that no child is disadvantaged by virtue of the fact that their parent(s) are unable to pay. Children in receipt of free school lunches may be eligible to have some of the cost of this revision guide paid for by the school. Parents do not have to pay for school lunches if they receive any of the following:

Income Support

Income-based Job Seeker's Allowance

Income-related Employment and Support Allowance

Support under Part IV of the Immigration and Asylum Act 1999

Child Tax Credit, provided they are not entitled to Working Tax Credit and have an annual income (as assessed by HM Revenue and Customs) that does not exceed £16,040

Working Tax Credit during the four-week period immediately after their employment finishes or after they start to work less than 16 hours per week

The guarantee element of State Pension Credit

Children who receive IS or IBJSA in their own right are also entitled to receive free school meals. Please contact the finance office if you need any help with payments towards this science revision guide.

In addition, your son/daughter should also have access to revision resources via the **GCSE Combined Science Classroom** with a unique class code of **7b1c7x**. Here they will find resources and activities posted over the next year to help aid revision. Each student also has access to **www.kerboodle.com** with their own unique username and password, here they can access online textbooks and resources.
